

Information and consent pursuant to art. 13 of European Regulation no. 679/2016 and national legislation on the protection of personal data for the processing of data of potential customers

Pursuant to art. 13 of the European Regulation on the protection of personal data (hereinafter also GDPR), Italdesign-Giugiaro S.p.A., as Data Controller pursuant to Article 24 of the GDPR, communicates the following information:

A) Data Controller and Data Protection Officer

The Data Controller is Italdesign-Giugiaro S.p.A., with registered office in Turin, via San Quintino 28 and operational headquarter in Moncalieri (TO), via Achille Grandi 25, which can be contacted by writing to privacy@italdesign.it or sending a registered letter to the attention of the Head of the Legal Department c/o Italdesign – Giugiaro S.p.A., via Achille Grandi 25, Moncalieri (TO).

The Data Protection Officer (DPO) can be contacted by sending an email to dpo@italdesign.it.

B) Subject matter of the processing

1. The data subjects to whom this information refers are potential customers of the Data Controller.
2. The personal data and information provided by the data subjects through the form to which this information is attached are as follows:
 - a. Name
 - b. Surname
 - c. Email
 - d. Phone Number
 - e. Company where the data subject works
 - f. Country in which the Company referred to in point e.
 - g. City in which the Company referred to in point e.
 - h. Zip code of the Company referred to in point e.

C) Purpose of the processing

The Data Controller processes the personal data referred to in point B) for the purpose of fulfillment of pre-contractual obligations.

D) Processing methods

In relation to the purposes indicated in point C), the processing of data is also carried out with the aid of electronic and automated means of a computer type, through terminals and PCs connected to the internal network and with the other companies of the

Volkswagen/Audi Group with central computers and, in any case, by means of tools suitable for guaranteeing security and confidentiality.

The data subject is hereby informed that the Data Controller, in order to store the data subject's contact details for pre-contractual purposes, will use external software previously assessed and considered technically suitable to guarantee the security and confidentiality of the data entered therein. Specifically, the Data Controller will store the data on Outlook and on the "Salesforce" platform, the technical and organizational measures of which can be viewed on the respective websites.

The Data Controller will process your personal data for the time necessary to fulfil the purposes referred to in point C. With regard to the data stored on Salesforce, the Data Controller will keep them for a period not exceeding 5 years from collection with the possibility of extending this period by a further 5 years at the request of the data subject. Data retention through Outlook, on the other hand, can vary from 2 to 4 years depending on the retention times set by those authorized persons to process it.

In any case, the personal data of the interested party will be processed in compliance with the methods indicated in art. 5 of the GDPR, which provide, among other things, that the data themselves are:

- processed lawfully and fairly;
- collected and recorded for specified, explicit and legitimate purposes;
- accurate and, if necessary, updated;
- relevant, complete and not excessive with respect to the formalities of the processing.

E) Legal basis of the processing

The provision of the data referred to in paragraph B for the purpose mentioned in paragraph C is optional, but their communication is strictly essential in order to be able to execute the pre-contractual obligations adopted at the request of the data subject. Any total or partial refusal to provide such personal data will preclude the possibility for the data subject to be contacted for any opportunities to collaborate with the Data Controller. Therefore, the legal basis of the data processing referred to in paragraph C is the fulfillment of pre-contractual obligations.

F) Subjects and categories of subjects to whom the data may be communicated

In addition to Italdesign-Giugiaro S.p.A. personnel in charge of the related administrative and IT management and in compliance with the purposes listed above, the above data may be communicated to the subjects listed below:

- Other companies of the Italdesign-Giugiaro S.p.A. group that may need it in the context of carrying out their activities;
- Other Volkswagen/Audi Group Companies;
- Consultants, collaborators and agents – individuals, companies and professional firms to which the Company relies (law firms, labor consultants, banking institutions, insurance companies, accounting firms, auditing firms);
- Public or private entities for the fulfilment of the obligations required by law.

G) Transfer of data abroad

The personal data of the data subject may be transferred to customer companies both internal and external to the Volkswagen/Audi Group, including those based in non-EU countries. In this case, the Data Controller hereby ensures that the transfer of data outside the EU will take place in the presence of one of the conditions set out in Chapter V of the GDPR. In exceptional cases in which the transfer will take place to non-EU countries in the absence of an adequacy decision or adequate guarantees and it will not be possible to guarantee the same standard of protection of personal data implemented in EU countries, the Data Controller will take care to ask the data subject for explicit consent before carrying out the transfer.

H) Rights of the data subject

In accordance with Articles 15 (Right of access), 16 (Right to rectification), 17 (Right to erasure), 18 (Right to restriction of processing), 20 (Right to portability), 21 (Right to object), 22 (Right to object to automated processing), 77 (Right to lodge a complaint with the Supervisory Authority) of the GDPR, the Data Subject may exercise his or her rights by writing to the e-mail address privacy@italdesign.it.

It should be noted that you have the right to revoke the consent given at any time by writing to privacy@italdesign.it.
